Human trafficking is often referred to as "modern day slavery," and can be labor trafficking, sex trafficking, or both; and is a growing concern in our state, yet few are aware of the problems within their communities. Preventing Human Trafficking in South Carolina is a main focus area within the State's plan to address the crime. Human trafficking is a hidden crime, and the first step to combating it is to identify victims so they can be rescued and help bring their perpetrators to justice. The more educated our communities, the closer we become in preventing individuals from being victimized. It takes various approaches including promoting the National Human Trafficking Hotline, awareness posters, billboards, and special events that generate dialogue in our communities.

Jeff McAninch is a Certified Senior Prevention Specialist with the Phoenix Center of Greenville, South Carolina, Greenville County's Commission on Alcohol and Drug Abuse. In October of 2004 Jeff began working the Phoenix Center of Greenville where he currently serves as Prevention Department Coordinator for the commission. During his time at the Phoenix Center, Jeff has served in the areas of Community Based Outreach, Medicaid Case Management, REACH Leadership and Resiliency Program Coordinator, Lead Prevention Specialist, and Prevention Department Coordinator. Jeff has served on many state and local coalitions and committees such as the Behavioral Health Services Administration (BHSA) Prevention Committee and the Blunt Truth South Carolina Marijuana Taskforce. Certified Senior Prevention Specialists are credentialed through the South Carolina Association of Prevention Professionals and Advocates (SCAPPA) as well as the International Certification and Reciprocity Consortium (IC&RC).

Kathryn A. Moorehead

Kathryn Moorehead is the Director of Violence Against Women Act (VAWA) and Human Trafficking Programs at the South Carolina Office of the Attorney General. Kathryn is also the Coordinator of the South Carolina Human Trafficking Task Force. She brings over 20 years of experience in the fields of education, social work, community advocacy, and public health.

Prior to joining the Office of the Attorney General, Kathryn was the Country Director for an international counter-human trafficking NGO overseeing their operations in Cambodia. She also consulted for a year in Guyana, South America with the country's only organization providing legal and support services to survivors of domestic violence and human trafficking. Her work experience includes therapeutic programming and community-based initiatives as well as partnerships with NGOs and governments in the United States, South America, Central America, Africa, Asia, and the Middle East. Kathryn was also a Research Assistant at Harvard University and an Integrated English Educator in the U.S. Peace Corps (Sri Lanka and Poland).

She graduated from Wheaton College in Norton, MA with a Bachelor of Arts in Political Science and earned a Master of Education in Risk and Prevention from Harvard University's Graduate School of Education. While in graduate school, Kathryn independently researched, filmed, and produced a documentary short film exploring the impact of community violence on adolescent girls in Boston. The film has been used at the graduate school in a course focused on trauma, interventions, and cross-cultural issues. She also earned a post-graduate certificate in Nonprofit Management and Leadership from Boston University's School of Management.

Kathryn is a member of the Board of Directors for the South Carolina Victim Assistance Network, represents South Carolina in the Southeast Regional Human Trafficking Advisory Group, the National Human Trafficking Compendium, and the National Human Trafficking & Disabilities Work Group. She is also a member of the SC Joint Council on Children and Adolescents, State Coalition for Youth Empowerment & Access, the National Association for Multicultural Education, and the Inter-Agency Network for Education in Emergencies. She was awarded the Wheaton College Alumnae/i Community Service Achievement Award in May 2012 and a Women of Influence Award from the Columbia Regional Business Report in June 2018.
