Synar Updates

STATE FY25 (FFY 2026) SYNAR STUDY

The study timeframe will be **December 9, 2024 – February 28, 2025,** or **March 7, 2025 – May 30, 2025**. This is dependent upon which group you are in.

- Group 1: Regions 2 and 3 are December 9 February 28. If you are requesting an extension due to extenuating circumstances, you must submit the request in writing to DAODAS by February 14, 2025. Paperwork must be mailed to DAODAS by March 7, 2025.
- Group 2: Regions 1 and 4 are March 7 May 30. If you are requesting an extension due to extenuating circumstances, you must submit the request in writing to DAODAS by May 9, 2025. Paperwork must be mailed to DAODAS by June 6, 2025.

Regions 2 and 3 must complete the "Synar Regulation: Implications for South Carolina" training on Relias between October 18, 2024, and November 8, 2024. Regions 1 and 4 must complete the "Synar Regulation: Implications for South Carolina" training on Relias between January 17, 2025, and February 7, 2025.

If an outlet you have received exists, as far as you know, but is not in your county, you must inform state Synar staff by December 6, 2024 (Regions 2 and 3), or by February 27, 2025 (Regions 1 and 4). You can lose your bonus for not doing this.

During the initial review process, if the coordinator has reliable knowledge that an outlet does not sell cigarettes and/or electronic nicotine delivery systems (ENDS), the outlet could be marked for non-consideration and replaced. All outlet exclusions must be confirmed with a telephone call or a physical site visit to ensure that the business does not sell tobacco products. If an outlet is deemed to not sell cigarettes and/or ENDS, inform DAODAS by December 6, 2024 (Regions 2 and 3) or by February 27, 2025 (Regions 1 and 4) to receive a replacement outlet. TEP Updates

Updated Process

The following steps must be followed before an individual is allowed to facilitate TEP on their own:

Individual must take the Relias self-paced recording of the new TEP curriculum. Then send this certificate to DAODAS.

Individual must attend a TEP TOT taught by a certified TEP instructor/facilitator.

Individual must facilitate a TEP class while being observed by a Certified Facilitator.

- At this point you will email DAODAS for access to the password-protected TEP materials located on the DAODAS website.
- This can be done with the certified facilitator attending virtually or in-person. The certified facilitator must provide feedback at the end of the observed class for the in-process facilitator in order for certification to be complete.

Open Conversations, JPK, and Embrace Recovery Campaign Updates

Utilizing various funding sources (SOR 25, State funds, ARPA, SUPTR BG, etc.:

DAODAS is working with State Procurement to post two RFPs: The first RFP will be for a media firm that can assist with developing content for running PSA spots for each campaign on various mediums (network/cable TV, streaming services and over-the-top television) during the grant.

The second RFP will be for DAODAS to secure a vendor that can provide content development and management of the three campaign's social media platforms when the previous vendor contract ends (February 2025-September 2025). The scope of work will include development of content (to include the creation of graphics), weekly management of the campaigns' social media channels and placement of content via paid and organic posts.

Finally, DAODAS will work with continue to work with various vendors such as I-Heart media for terrestrial radio and streaming platforms; National CineMedia (NCM) to air PSA messages before new release movies in the theaters across the state; and work with colleges/universities in South Carolina to place ads on the college campus venues such as football, basketball and baseball stadiums, digital boards in the library, dinning hall and student centers. DAODAS will also seek additional large-scale events in SC to place messages in the communities such as high school state championship sporting events, NASCAR, SC State Fair, etc.



Community-Based Processes •

Provides ongoing networking activities and technical assistance to community groups or agencies using action planning and collaborative systems planning.

Environmental -

Establishes or changes written and unwritten community standards, codes, and attitudes, thereby influencing incidence and prevalence of the abuse of ATOD.

Alternatives ▼

Participation of target populations in activities that exclude ATOD use.

Information Dissemination •

Characterized by one-way communication from the source to the audience, with limited contact between the two.

Education -

Involves two-way communication and is distinguished from Information Dissemination by the fact that interaction between the educator and/or facilitator and the participants is the basis of its activities.

Problem ID & Referral -

Aims to identify those who have indulged in illegal/age-inappropriate use of ATOD, and those who have indulaed in the first use of illicit drugs, in order to assess whether their behavior can be reversed through education. This strategy does not include any activity designed to determine if a person is in need of treatment.

SOR Updates

Intervention Services: Harm reduction contracts for overdose reversal agent, fentanyl test strips and xylazine test strips are in the process of being sent out to agencies.

Primary Prevention Services: DAODAS is working on an RFP to fund up to 10 local community coalitions or non-profit organizations to implement evidence-based primary prevention educational programs with the goal of reducing the consequences of opioid misuse among youth and young adults in South Carolina.

A minimum of 100 school-aged youth/young adults from each site, for a total of 1,000 across the state, will be reached each year of the grant. The organizations will select an evidence-based program from a list provided by DAODAS and must be implemented with fidelity to maximize the potential for desired positive programmatic outcomes.

In addition to the requirement of implementing the educational program, funded sites must also select other primary prevention strategies to implement based on their local community data. Strategies can include information dissemination, alternative and/or environmental primary prevention activities to increase protective factors and reduce risk factors among youth and young adults related to opioids and stimulants in their community.
